5. For the nomination to be accepted, all the details concerning the person's name, age, family, employment, civic and religious life, along with the activities and accomplishments that make this person worthy of the award, must be in the Chamber office in writing no later than December 31, 2009. This award will be presented at the Annual Banquet on January 21, 2009.
