The 2022 Dunn Christmas Parade is Saturday, December 3 at 2:00 p.m. Line up begins at 1:00 p.m. Please note the full rules and appropriate entry points for your unit type.

Each unit will be reviewed upon arrival for rule compliance. The Dunn Area Chamber of Commerce reserves the right to refuse admission at the discretion of the chamber. A **general map** of the line-up area is attached for your use – note this map is not numbered, line up placement is approximate. Please make note of you appropriate entry point based on unit type.

- ⇒ **Individual Vehicles** (classic cars, beauty queens, business entries (personal trucks, SUVs or cars only) - enter at W. Harnett Street and N. Orange Avenue.
- ⇒ **Walkers/Float Riders**—Drop off for riders/participants is allowed at the corners of W. Harnett St. and N. Orange Ave. or W. Harnett St. and N. Wayne Ave. Parking is available at the Tyler Park lot off Wayne Ave. (spaces are limited—please carpool when possible).
- ⇒ **Commercial Transfer Trucks, Large Units/Floats, Fire and Rescue vehicles** park in the T-Mart Parking Area designated on map, corner of N. General Lee Ave. and W. Broad St. and then immediately check in with parade official for further instructions.
- ⇒ **Marching Bands/JROTC Unit** – Enter staging area at the intersection of W. Broad St. and N. Wayne Ave. Parking is available in the Kim's BBQ parking lot or at end of parade route at N. Elm Avenue near City Hall. Exit parade staging area at entrance—proceed to City Hall via Hwy 421.
- ⇒ **Dance/Performing Groups**—Stand still performances are limited to 60 to 90 seconds so the parade will not be delayed. **NOTE DROP OFF AREAS FOR PARTICIPANTS.**
- ⇒ **Commercial/Professional Float Riders (floats provided by the DACC)** – Drop off for riders at the car pool entrance to Harnett Primary school (off N. Orange Avenue) – no long-term parking allowed, only drop off. Do not block entrances with cars.
- ⇒ **HELMETS ARE REQUIRED FOR ALL MOTORYCYLCE/ATV RIDERS—NO EXCEPTIONS!** Horseplay (including tire screeching, wheelies (front or back), or excessive engine revving is not allowed and will not be tolerated – offenders will not be allowed to participate in the parade.
- ⇒ **NO VEHICLES WILL BE ALLOWED IN THE LINE UP AREA UNLESS IT IS A REGISTERD UNIT.** If you have riders participating with your unit—please make them aware of all drop off areas at W. Harnett St. and N. Orange Ave. or at W. Harnett St. and N. Wayne Ave.

Please keep the following rules in mind:

1. MAKE EVERYONE IN YOUR UNIT AWARE OF YOUR **LINE-UP NUMBER**
2. Be in your line-up space (**denoted by orange cone with number**) by **1:00 p.m.**
3. **No loud sirens, horns, or explicit lyrics** will be allowed throughout the parade route.
4. The **Parade Contact person** assumes responsibility for their units and all riders.
5. **NOTHING CAN BE THROWN FROM ANY UNIT FOR EVERYONE'S SAFETY.**
Walkers may hand items out. Units throwing items may not be allowed in future parades.
6. **Weapons at parades, etc., prohibited.** North Carolina General Statute 14-277.2
7. **PLEASE NO SANTA CLAUSES!** Santa is on the final float.
